- •Mission Fund: since 1944, this fund contributes to mission as the donor may determine.

- •Mirmiam Snow Mathes Internship Fund: To be used only in support of one or more seminary students, to have internship experiences of up to one year in local congregations within the bounds of the Presbytery of Alaska and the Presbytery of Yukon.
