## **ELDER COMMISSIONER TESTIMONIES**

## **New Hope Church** – RE Ron Illingworth

Having recognized a call to the ministry, member Mary Ann Smith has enrolled in seminary through a distance learning program. The church's preschool is nearly almost full, with a waiting list at times. The church council is looking at how to expand alternatives, e.g., perhaps offering preschool in the afternoon, providing opportunities for new people to worship, and enacting changes in ministry as the military presence changes.

## Atqasuk Presbyterian Church – RE Elizabeth Hollingsworth

Elizabeth gave thanks for the flame of the Holy Spirit who continues to be present. Fellowship is strong on Sunday and Wednesday, with refreshments, singing, and visiting with each other. The congregation is blessed with the musicians - the new school teacher in the village plays the piano and her husband the guitar. Thanks be to God for those teens who stay for the entire worship service. A partnership with the city helps the church's food bank to be financially secure, but there are issues which need to be ironed out. The food bank is the primary contact with people not attending worship, so a Bible is distributed with each box of food. Technology will be enhanced with fiber optic coming to the village.

## First Anchorage Presbyterian Church – RE Jim Powell

Deferred maintenance is the name of the game. With the church hosting a charter school and several community groups during the week, it is important to have the building in good working order. The congregation continues to serve as a 'cold weather shelter' for homeless families one night a week. A number of homeless people attend worship on Sunday morning and some stay for Sunday school. The organ has been upgraded. Membership is growing, with nearly a dozen new members joining in the last month.

## Kuukpik Presbyterian Church – CRE Virginia Kasak

Virgie expressed gratitude to Curt Karns for moderating the December congregational meeting. Two new elders were elected but there are no deacons serving the church. With the assistance of her children and grandchildren, Virgie has been distributing food to individuals in need. Sunday worship attendance may be only 3 – 4, but God remains in their midst. No Sunday school is offered. One of the young men leads an occasional, spontaneous sing-a-long. A contingent from Canada are planning to visit this spring.

Rev. Neill McKay led in the prayer for these churches.

## ELDER COMMISSIONER TESTIMONIES

# Utqiagvik Presbyterian Church – RE Ida Olemaun

There is much to be thankful for: Membership increased by 13 this past year. The church continues to sponsor the Presbyterian Hour, a 9:30 – 11:30 pm radio program that reaches across the North Slope into Northwest Territories in Canada and south to Anchorage. Services are recorded on YouTube. The congregation is blessed to have Wendy Christianson oversee the Christian Education program and the pastor and volunteers teaching Sunday school. The congregation receives a benefit from Joseph Reid's preaching; attendance has been high during these services. On March 2<sup>nd</sup>, the Utqiagvik PC choir will be participating in the Musicale at Change Point Church. A regular visitor has donated a new sound system for the church which enables the service to be heard in the upstairs classrooms when there is overflow crowd. Demand for the church's food bank is high, an average of 100 people a month are fed. Church staffing is stable now. The bookkeeper has done a good job with the books, and giving has increased. Session members lead some of the funerals. The people "are a people of grief" – there were four in just one week. The concept of having a local, ecumenical faith-based recovery program is being well received.

## **Anchor Presbyterian Church** – pastor Rev. Britt Johnson

The church's main focus is to the native population and the homeless, through hospital visitation, providing a bagged lunch every Sunday and a monthly Sunday potluck, and inviting people to attend worship, which can be challenging for dealing with those afflicted by mental illness. With a dwindling church membership, there are too few willing to serve on session. Church leaders reached out to presbytery, which appointed an Administrative Commission to serve as the session. Church records have been lost, so assistance is needed to reconstruct records going back a decade. The congregation is part of a prayer network for the native churches in Alaska.

# University Community Presbyterian Church – RE Randy Frank, RE Paula Long

There is much to be thankful for. Of eight elders on session, five are new members and three have never served as elders before. The church is growing. Session agreed that the church will be available to marry same gender couples, provided the service is a Christian service and the pastor is not forced to preside. The congregation's outreach within the Fairbanks community is wide: food was donated during the Souper Bowl offering; the church is host to homeless families who stay at the church a week at a time on a rotating basis; and the congregation continues to be involved in Love, INC's ministry and supports *The Door*, a shelter for youth. Visionaries bring together those from various denominations to form a gospel choir and many community groups meet at the church on a regular basis. UCPC has been designated as an official earth care congregation.

#### Immanuel Presbyterian Church – RE Candace Arlian

The congregation has a long running tradition of helping Nunaka Valley Elementary School, by providing school supplies and a community dinner. On a less joyous note, the church was the victim of a break-in in January.

## Savoonga Presbyterian Church – moderator Rev. Leisa Carrick

Rev. Carrick provides parish support for Saint Lawrence Island. The church has no functioning session and Leisa asked for prayers in raising up leadership. The church is especially important to the community. Its food bank recently distributed food boxes to 400 families, and elders are involved in the whaling service and funerals. Kindergarten school teacher and Assembly of God minister Heidi Secor, preaches and leads Sunday services to an estimated 15-20 worshipers.

Rev. Leisa Carrick led in the prayer for these churches.

# EXECUTIVE PRESBYTER'S REPORT – Rev. Curt Karns

Rev. Curt Karns highlighted his written report (Appendix A)

## PERSONNEL REPORT - Rev. Matt Schultz

The Committee chair recommended that the exec be adequately compensated for the work he is doing with Intergenerational Arctic Ministries (IAM). IAM will contract with the presbytery for Rev. Curt Karns services. Curt explained that he would be working half time for the presbytery and half time for IAM, with each entity paying half. Curt recommended that presbytery approve the terms on principal, and let the Ministry Commission sign off on the contract. Presbytery **APPROVED** a change to Rev. Karns terms of call, by splitting the retirement savings and additional medical equivalent (i.e., change in retirement and medical lineitems in his call from one line to two lines). This proposal would be reviewed in 90 days.

With few pastors in the Native Ministries region, Curt expects that most of his presbytery work will involve the Native Ministries region. The Leadership Team/Ministries Commission will provide assistance with the road system region.

Rev. Schultz led in a prayer for the presbytery staff.

## LEADERSHIP TEAM (LT) REPORT - Rev. Piper Cartland

The LT chair reported that the team is trying to work into the new structure. The following written report heighted actions of the Leadership Team, which functions as the presbytery's Board of Directors.

# Actions of the Leadership Team taken since the Fall 2017 Presbytery Stated Meeting:

- January 6, 2018 teleconference
  - 1. Designated Philippians 1:3 6 as the theme verse of the 2018 Winter Stated Presbytery Meeting. "I thank my God every time I remember you, constantly praying with joy in every one of my prayers for all of you, because of your sharing in the gospel from the first day until now. I am confident of this, that the one who began a good work among you will bring it to completion by the day of Jesus Christ."
  - 2. The Leadership Team proposed that ruling elder commissioners address the following questions in their reports:
    - a. Tell what you are thankful for?
    - b. What partnerships do you see your congregation blessed by now and in the future
  - 3. In response to the drawn down of operating fund cash reserves in 2017, the Leadership Team approved a motion recommending that the remainder of the money in the Mary Jane Landstrom Fund, be used to make up for a portion of the lack of income in 2017..
  - 4. Curt Karns, Joseph Brock, Bob Christensen, Mary Kron, and Sharon Rayt were appointed to a sub-committee to have a conversation as to what financial sustainability looks like. Others may be co-opted as needed.
  - 5. Bob Christensen, Joseph Brock, and Israel Nelson were appointed to the newly formed Investment Committee. Curt Karns and Sharon Rayt will serve as ex-officio members, without the right to vote. Financial secretary Mary Kron will be called upon as needed.
- February 22, 2018 regular meeting
  - 1. The Leadership Team endorsed a proposal to encourage legacy giving in our congregations through the Presbyterian Foundation's planned giving navigator program and accepting First Presbyterian Church, Wasilla's offer to match Presbytery's \$1,000, in support of the program.
  - 2. The Leadership Team approved a recommendation to cash out the \$357,717 Synod Mission Development Certificate which matures in March, 2018. Money will be needed upfront to pay costs associated with completing the project. Funds from the M.J. Murdock Charitable Trust grant will not be awarded until

completion of the Gambell building project. Furthermore, grant moneys may not be used to pay costs associated with finishing the apartment.

#### AFTERNOON RECESS

Presbytery recessed at 3:50 pm.

#### **RECONVENE**

Presbytery reconvened at 4:15 pm, with moderator-elect Paula Long stepping in to serve as acting moderator.

## **ELDER COMMISSIONER TESTIMONIES**

## **Chapel in the Mountains** – RE Vera Lincoln.

The church began in 1959 as a mission of Utqiagvik Presbyterian Church. The congregation is still grieving the loss of Rev. James Nageak in December and having trouble with Sunday morning services since James' death. Only two elders currently serve on session, with elder Casey helping with the youth. Vera is a praying person and conveyed her hope by sharing Romans 15:13. She prays for growth in the church, for Sunday school, and for high schoolers who are hungry for the gospel. Youth group will begin soon on Wednesday evenings; a young man leads music. Groups from Trinity Presbyterian Church and Peter's Creek lead Vacation Bible Schools. A senior van transports elders to Sunday worship. Now that the plumbing works, session is thankful that the church is back in operation. Extra income is received by renting out the manse.

## **Trinity Presbyterian Church** – RE Dick Henningsen

For the past five years, Trinity had a host of problems, and membership dropped drastically. Rev. Mark Klohe came in as an interim and provided immediate first aid, followed by interim Rev. Todd Allen. The Pastor Nominating Committee (PNC), wanting the right spiritual leader, worked on God's time, rather than their own. After reviewing 150 resumes, the PNC found local ministers, Revs. Richard and Mary Koch to serve as copastors. Both are former pastors of a local congregational church. Mary will oversee office duties, home and hospital visitations. The church will soon host a new members' class and is searching for a music director and youth director.

# Delta Presbyterian Church – RE Ann Geise

Ann expressed thanks for the combined Delta Presbyterian/Faith Lutheran church family and pastor Mauer. The church community is reeling over a number of deaths these past six months – former pastor Richard Carpenter, elders Bob Lee, pastor Mauer's wife Ann, and other members of the congregation. The church partners with Faith Lutheran church in worship and with the 7<sup>th</sup> Day Adventist Church in Project Christmas. The session/council hopes to form more partnerships with other churches in the area. Pastor Mauer usually leads up the National Day of Prayer service in City Hall. The church handbell group has a good time. An exercise group meets at the church three times a week.

## Jewel Lake Parish – Elder Susan Woods

The congregation serves the hungry through its support of Lutheran Social Services by providing canned food each month and volunteers at the Food Bank of Alaska's Mobile Food Pantry. The congregation rejoices over the five new members, including three from Cameroon, and a new birth, but grieves the passing of a long time member.

Rev. Joseph Reid led in the payer for these churches.

## FINANCIAL REPORTS – RE Bob Christensen and Mary Kron

**2018 Budget:** The Leadership Team had high hopes that presbytery would receive an estimated \$200,000 in support from our churches this year, but we have received only \$81,000 in pledges to date.

**2017 Budget:** The 2017 year-end financial statement, budget and Hillcrest Loan activity report (Appendix B) was distributed. Mary Kron provided comments. Even though presbytery underspent its 2017 budget, cash

reserves had dropped to \$12,000 by the end of December. By its own rule, presbytery must maintain \$75,000 in reserves. Money from the Mary Jane Landstrom special fund was transferred in January 2018 to cover this shortfall.

Barbara Brown, Britt Johnston, Lauri Kari, Curt Karns, Vera Lincoln, Neill McKay, Israel Nelson, Beulah Nowpakahok (via phone), and Helen Woodings, addressed different aspects of caring for God's creation [not appearing in any special order]: effects of global warming on village communities, recycling, stopping heat leaks in buildings, clean waters, submitting overtures to the next General Assembly, divestment of fossil fuels and supporting alternative fuels. The exec presented University Community PC elders with a basket of fair trade items, in recognition of UCPC being the first certified earth care congregation in the presbytery.

# GAMBELL NEW BUILDING UPDATE - CCE Danna Larson, RE Dennis Berry

Project volunteer coordinator Danna Larson gave thanks for the prayers, financial support and hard work by volunteers. Six teams of volunteers (50 people) worked on the building last summer, including three groups from the lower 48. About 80 volunteers will be needed to help complete the work this summer. Piper Cartland recognized Danna for the countless volunteer hours she put in to coordinate and promote the Gambell building project. Curt Karns led in a prayer for Danna.

Project director Dennis Berry reported that the goal is to complete construction this summer. Work remaining includes installing the sprinkler system, sheetrock, remaining electrical, duct work, plumbing, painting, cabinetry, and flooring. A major frustration has been the lack of a regular, on-site construction superintendent. The search for a superintendent continues.

## MISCELLANEOUS REPORTS

#### **Bingle Camp Report**

Camp executive director Steve Spencer reported that no camps were scheduled last summer. The summer was spent renewing and refurbishing some of the facilities. Foundation work was done on the chapel, and significant work was done on the retreat center, in an effort to make it fully handicap accessible. Most of the retreat center is now wheelchair accessible. An upgrade led to a reduced fuel oil consumption of 25%.

As a community outreach event, the camp hosted the 'largest, on-the-water concert' last summer. This was possible because the camp has the only large beach with water deep enough to float boats. Upwards of 600 people attended the concert. The camp board hopes that attendance will increase at this summer's event.

Board member Henry Woodall reported that camps are planned for this summer. In addition, an 'Upward, Inward, and Outward' camp targeting teens from churches within the presbytery is scheduled for May 27 – June 2, 2018. Camp staff needs for this summer include counselors (especially male), a cook, and summer camp program director.

The summer camping program is not enough to totally support the camp financially, but rental of its facilities to outside groups has helped make ends meet.

Even though the camp is independent of presbytery, it is under the oversight of presbytery. According to Rev. Woodall, the camp is in better shape administratively, than it has been in the past. There is treasurer, but a financial audit needs to be done soon. Henry led in a prayer for the camp and its executive director.

# **Regional Meeting Reports**

<u>Native Ministries:</u> Ida Olemaun reported that it was unfortunate that the St. Lawrence Island people were unable to get off the island. The proposed *Listening Way* program is being introduced to each of the villages, with presenters seeking input from each community to determine each community's particular needs. Joseph Reid and Curt Karns will travel to St. Lawrence Island soon to introduce the concept to Gambell and Savoonga. Presbyters were asked to pray for this program and for the recovery of individuals dealing with addictions. Monthly telephone support meetings for community leaders began in January.

Road System: Matt Schultz reported that the region elected new regional officers [Moderator – Luke Jones and Vice Moderator – Marjorie Poggas] and a regional representative to the presbytery nominating committee [Danna Larson.] The region is looking at Native Ministries founding document to use as a starting point for drafting a document outlining the road system's purpose. Free flow conversation centered on racial/ethnic issues in the church and church security issues.

## MINISTRY COMMISSION - RE Jan Burger

## **Action Item**

Recommendation to approve changes to 2018 terms of call for installed pastors (Appendix D). Elder Burger identified those installed pastors whose terms of call are not in compliance with presbytery's minimums, i.e., do not provide the minimum required medical leave. Presbytery **APPROVED** changes to 2018 terms of call for installed pastors, with the understanding that the Ministry Commission will follow up with churches not providing the presbytery minimum for medical leave.
