### PRESBYTERY OF YUKON

Special Zoom/Teleconference Meeting December 4, 2021 DRAFT MINUTES

## **CONVENE**

Presbytery moderator Denny Berry convened the video/teleconference at 10:04 am with Elizabeth Schultz leading in the opening prayer.

### DECLARATION OF QUORUM

A quorum was present in accordance with presbytery's bylaws and G-3.0304, in that at least 10% of members and no fewer than three elders representing at least three churches and three ministers were present.

### **AGENDA**

The special meeting was called by moderator Dennis Berry, with the concurrence of Rev. Leisa Carrick, Rev. Henry Woodall, elder Jan Burger (United Protestant Church) and elder Shirley Novak (First Wasilla PC) to act on business identified in the call to the meeting

### **Ministry Commission recommendations** – Debbie Melton

- That Rev. Seung Hyun Yoo be examined for membership in the Presbytery of Yukon. Rev. Yoo has been called by First Korean Presbyterian Church in Anchorage to serve as installed pastor beginning December 1, 2021. The Ministry Commission examined Rev. Yoo and has concurred with calling Seung Hyun Yoo. He was ordained in South Korea on April 18, 2007 and is a member of the Presbytery of San Francisco (PCUSA). Rev. Yoo read his statement of faith and responded to questions from presbytery. Motion to receive Rev. Seung Hyun Yoo as a member of the Presbytery of Yukon was APPROVED without objection. The transfer is conditional on his membership release from the Presbytery of San Francisco. Rev. Leisa Carrick led in a prayer for Rev. Yoo.
- [In accordance with G-1.0502] that presbytery call a special meeting of the Trinity Presbyterian Church congregation for the purpose of electing an elder for the purpose of increasing the number of elders on session to the minimum required by Trinity's bylaws. Time is critical as session will be required to approve Rev. Alison Burchett's proposed stated supply contract. Motion to call a special congregational meeting for Sunday, December 5<sup>th</sup> during worship, was **APPROVED** without objection. The worship service will briefly pause for the meeting, to be moderated by Piper Cartland. Worship will recommence at which time the elder will be installed.

• That Rev. Alison Burchett be examined for membership in the Presbytery of Yukon. If the way is clear, Rev. Burchett will serve Trinity PC as their stated supply pastor starting January, 3, 2022. She has been examined by the Ministry Commission, which has approved her proposed contract. Alison was ordained by Cimarron Presbytery on October 2, 2021 and currently serves as an interim pastor in Enid, Oklahoma. Rev. Burchett read her statement of faith and responded to questions from presbytery. Motion to receive Alison Burchett as a member of the Presbytery was APPROVED without objection. The transfer is conditional on contract approval by session and membership release from Cimarron Presbytery. Leisa Carrick led in a prayer for Rev. Burchett.

To enable presbytery to respond and support churches in the future on a timelier basis, the Ministry Commission further recommends:

- That the Ministry Commission be granted authority to call congregational meetings on behalf of the presbytery. G-1.0502 grants presbyteries the authority to call congregational meetings. Motion was **APPROVED** without objection.
- That the Ministry Commission be given the authority to appoint an Administrative Commission with the full powers of a session, as an act in support of a church which does not have a legally constituted session as defined by the Book of Order and/or church bylaws. Administrative Commission members should include remaining elders on session. Motion was **APPROVED** as amended (replacing *should* with *shall* in the last sentence) and without objection.

These two motions will be added to the Ministry Commission's list of delegated duties as delineated in Presbytery's Standing Rules. Given that the time between stated presbytery meetings is so long, it was suggested that presbytery be informed of the more important actions taken on behalf of the presbytery by the Ministry Commission.

# Nominating Committee – Shirley Novak

Of the six General Assembly commissioner/Young Adult Advisory Delegates (YAAD) positions, five remain unfilled. Rev. Ellen Johnson-Price was elected in October as the Principal Minister Commissioner. On behalf of the committee, Shirley Novak presented the following slate of nominees:

There were no nominations for General Assembly Alternate Elder Commissioner and Alternate YAAD. The floor was open for nominations. There being none, motion to close nominations and cast a unanimous ballot was **APPROVED** without objection.

## **Stated Clerk's Report**

- Action Request
  - That presbytery directs the stated clerk to submit a report of church records reviewed by the end of the year and to attach the report to these minutes. Motion was **APPROVED** without objection.
- Correspondence Received
  - At its October 20, 2021meeting, the Synod of Alaska-Northwest approved the distribution of remaining cash and Presbyterian Foundation earnings (based on donor restrictions) to its presbyteries. The Presbytery of Yukon's share is to be used in accordance with the following Foundation restrictions:
    - \$168.25: Housing Ministry Fund for housing ministry or homeless ministries within bounds of the presbytery

- o \$86.73: Mission Fund (NMPF) for mission needs, as determined by your presbytery
- \$141.19: Elias Foundation (0028) Christian Education within Synod for scholarship or program, where need is greatest.
- \$2,047.26: Armenta Merchant Fund (0676) mission support for small congregations in Alaska; consult with presbytery within Alaska. Allocated same way as Elias.
- o \$437.57: Armenta Merchant Fund (5348) for small congregations and missions in Alaska
- o \$121.92: Janette Hansen Fund camps in your presbytery
- o \$164.10: Underwood Fund aviation mission within Synod/Alaska/Yukon travel
- o \$592.88: Morris Evangelism Fund evangelism focus
- o \$151.84: Schaffer Family Foundation as determined by presbytery leadership.
