Special Meeting June 9, 2016

CONVENE

Moderator Ruling Elder Ron Illingworth convened a teleconference meeting of the Presbytery of Yukon at 9:35 am with prayer.

DECLARATION OF QUORUM

A quorum was present in accordance with G-3.0304, that ruling elders representing at least three churches and three teaching elders constitute a quorum.

<u>AGEN</u>DA

The special meeting was called by moderator RE. Ron Illingworth with the concurrence of Rev. Piper Cartland, Rev. Henry Woodall, ruling elder Arlayne Knox (University Community PC) and ruling elder Sharon Rayt (Jewel Lake Parish), to act on the following items of business:

- Appoint Administrative Commissions (AC) for First Korean Anchorage Presbyterian Church and Fairbanks Korean Presbyterian Church for the purpose of serving as the sessions until new ruling elders/deacons are elected, trained, ordained and installed.
 - First Korean Presbyterian Church, Anchorage: Along with Rev. Johan Shin, there is only one ruling elder currently serving on session, not enough for a quorum. Presbytery APPROVED the appointment of church pastor Rev. Johan Shin, who will serve as moderator; RE Steve Bang (First Korean Anchorage PC); Rev. Tim Carrick, who will serve as an English secretary; RE Joseph Brock (United Protestant Church); and RE Sara Johnston (Immanuel PC) to the First Korean Anchorage Administrative Commission, which shall have the full authority of the session; dismissal of the AC to take effect after the installation of elders and deacons and submission of the commission's final report to the stated clerk. Duties of the Administrative Commission will be to help the session to oversee circumstances and make decisions which require session approval in accordance with the Book of Order and the church's bylaws, (e.g., calling of a congregational meeting or helping to bring resolution to any incidences which may require the session's attention.)
 - Fairbanks Korean Presbyterian Church: Along with CRE Cody Ryu, who serves as
 the moderator, there is only one ruling elder currently serving on session, not enough for
 a quorum. The Presbytery APPROVED the appointment of church pastor CRE Cody

Ryu, who will serve as moderator; Rev. Curt Matz; Rev. Neill McKay; RE Jinhee Dickerson (Fairbanks Korean PC), and RE Mark Wartes (Utqiagvik PC), to the Fairbanks Korean Administrative Commission, which shall have the full authority of the session; dismissal of the AC to take effect after the installation of elders and deacons and submission of the commission's final report to the stated clerk. Duties of the AC will be to help the session to oversee circumstances and make decisions which require session approval in accordance with the *Book of Order* and the church's bylaws, (e.g., calling of a congregational meeting or helping to bring resolution to any incidences which may require the session's attention.)

- Nominations and elections for two regional geographic elder representatives to the Leadership Team, class 2017. Due to an oversight, leadership team members RE Arlayne Knox (interior region) and CRE Beulah Nowpakahok (western region) were inadvertently omitted from the Winter Stated Presbytery Meeting nominating slate. Both elders are willing to serve a second term. The floor was open for nominations. There being none, Presbytery APPROVED a motion to close nominations and cast a unanimous ballot for RE Arlayne Knox and CRE Beulah Nowpakahok as the Leadership Team's interior and western area representatives, respectively, class 2017.
- Receive the 2015 presbytery statistical report and church membership report. Motion to receive the reports (attached) was **APPROVED.**
- Approve the proposed revision of the presbytery's Investment Policy. President of the Board of Trustees, Rev. Israel Nelson presented the proposed policy. Discussion ensued. Motion to postpone action on the policy and refer it back to the Board of Trustees, was APPROVED.

The meeting adjourned at 10:20 am with Rev. Curt Karns leading in the closing prayer.
