TRAINING EVENT GATHERING

Elders, ministers, and guests gathered in the church's fellowship hall, at 9:00 am. host pastor Rev. Presbytery moderator Commissioned Pastor (CP) Beulah Nowpakahok led in a reading of God's Word and opened with prayer.

The Alaska Training Cooperative provided eight hours of Mental Health First Aid training, the aim of which is to help the layperson assist someone experiencing a mental health crisis until appropriate professional help arrives.

FINANCIAL REPORT

Mary Kron answered questions about the 2019 Year-End Financial Statement and Budget (Appendix A) and year-to-date 2020 financial reports. The \$200,000 received from the M.J. Murdock Charitable Trust Loan was applied towards the Gambell PC loan. Presbytery has received \$128,173 from the Synod of Alaska/NW, of which \$105,000 is undesignated and \$23,173.44 comes with restrictions.

MINISTRY COMMISSION

Henry Woodall extended gratitude to exiting co-moderator Jan Burger for her six years of faithful service, as moderator of the Committee on Preparation for Ministry, followed by her leadership on the Ministry Commission.

Presbytery of Yukon ministers will gather with pastoral leaders of the Evangelical Lutheran Church in America for boundaries training, April 21 - 23, 2020.

Ministry Commission (MC) Recommendations for Action

- 1. That Presbytery affirm the dismissal of the First Korean Anchorage PC Administrative Commission (AC) with thanks. Upon appointing the Administrative Commission in June 2016, the presbytery granted the AC with the full authority of a session, until such a time that enough elders had been elected, trained, and installed to constitute a full session, and the AC would be automatically dismissed. The last elder to constitute a full session has been ordained and installed. Motion was **APPROVED**.
- 2. That Presbytery extend the Administrative Commission for Anchor Presbyterian Church for another year. In April, 2018, the presbytery appointed an AC for a period of up to two years, for the purpose of performing the duties of a session and helping the Anchor congregation discern its future direction. Given that its work is not finished, the AC has requested a one-year extension. Motion was **APPROVED**. The Administrative Commission's periodic report is attached (Appendix B).
- 3. That Presbytery approve changes in 2020 terms of call for installed pastors (Appendix C). Motion **APPROVED.**
- 4. That preparation for ministry inquirer Jennifer Pottinger be examined for candidacy. Jennifer's under-care relationship was transferred to the Presbytery of Yukon after she relocated to the Fairbanks area. Motion was **APPROVED.** Questions were limited to Jennifer's Christian faith, forms of Christian service undertaken, and motives for seeking ministry. Inquirer Pottinger read her statement of faith before answering questions from the floor. As a long-distance student at Fuller Seminary, Jennifer is expected to complete her studies later this year. She is employed with the Alaska Air Guard and has received the full endorsement of New Hope Church. Jennifer was escorted out of the room after the examination had concluded. Rev. Curt Matz and CP Matt Tinkelenberg will serve as her mentors. Within a month, Jennifer will begin Fuller Seminary's required 9-10-month apprenticeship at New Hope Church. Motion to move Jennifer Pottinger to the candidacy phase was **APPROVED.** Jennifer joined the plenary session amid the acclamation 'Rejoice in the Lord'. Rev. Curt Matz led in a prayer for candidate Pottinger.
- 5. That Rev. Dale Richesin be examined for temporary membership. Motion was **APPROVED**. After Rev. Richesin read his statement of faith, the floor was opened for questioning. Rev. Richesin completed a two-year internship at First Presbyterian Church in Chicago and earned his D. Min. from the Divinity School of

the University of Chicago. He was ordained in 1979 by the Christian Church (Disciples of Christ), worked at the Chicago Baptist Institute teaching Old Testament and resided in Togiak for 14 years, where he did some pulpit supply for the Moravian Church. Dale is currently serving Chapel in the Mountains as a temporary supply pastor in addition to his duties as principal at Nunamiut School in Anaktuvuk Pass. Dale preaches for the morning service, and Derrick Zuk leads Sunday school and Sunday evening services. Rev. Richesin also served as a drug and alcohol counselor in Chicago for 10 years. Chapel in the Mountains has now started AA and Al-teen groups, which are meeting on a regular basis. Dale was escorted out of the room after the examination had concluded. Motion to receive Rev. Dale Richesin as a temporary member of the Presbytery of Yukon was **APPROVED.** The Inupiat choir sang 'At the Cross' upon his return. Rev. Henry Woodall led in a prayer for Dale.

Ministry Commission delegated actions (taken subsequent to the 2019 fall stated presbytery meeting.)

- 1. Minister Status: The Ministry Commission has the responsibility of reviewing the status of members-at-large annually. [February 27, 2020]
 - **Rev. Wendy Christianson**: In light of Wendy's work as assistant pastor at Utqiagvik P.C., the Ministry Commission changed her status from member-at-large to engaged in validated ministry.
 - **Rev. Elizabeth Schultz:** Member-at-Large status was renewed for another year, which was based on her responses in the annual report filed with the Ministry Commission:
 - Ways in which the minister is related to the life and work of a particular congregation: I
 worship and volunteer at First Anchorage PC. As an ordained minister, I serve in worship,
 preach, administers the sacraments, lead a quarterly woman's book study, volunteer with church
 mission and offer pastoral care.
 - List the ways in which you are active in the life and work of the presbytery: I serve on an
 Administrative Commission that serves as the session of the Anchor PC. I also have provided
 pulpit supply throughout the presbytery, preaching at First Anchorage PC, Eagle River PC, and
 Immanuel PC.
 - List the ways you are active in other ecumenical religious/ecclesiastical activities: I attend Christians for Equality and other interfaith gatherings as able.

2. Minister Contracts

• The MC concurred with the action of the Immanuel Presbyterian Church session to renew **Rev. Ellen Johnson-Price's** pastoral supply agreement for another year, retroactive to January 1, 2020. This is a part-time position (28 hours/week). [February 27, 2020]

- The MC concurred with the action of the Trinity Presbyterian Church session to renew the stated supply contract of co-pastors **Rev. Richard and Rev. Mary Koch** for the period March 1, 2019 September 30, 2020. Compensation will be split 50-50 between the co-pastors, except as noted, for approximately 40 hours of work. [electronic vote].

Terms of compensation

- The MC approved the Assistant Pastor for Children and Youth Ministries contract for **Rev. Wendy Christianson**, for the period January 1, 2020 through December 31, 2020. This is a part-time, tentmaking position (up to 10 hours/week), making it possible for Wendy to maintain full-time employment elsewhere in Utqiagvik which provides a salary as well as full health and retirement benefits. The assistant pastor will be paid \$1,500 monthly. [February 27, 2020]
- 3. Commissioned Pastor Commissions Renewed [February 27, 2020]
 - **Joseph Brock** (United Protestant Church): The Ministry Commission approved the request of the session to renew Joseph's commission for three years. Responsibilities granted under this commission: lead worship services and preach the gospel; administer the Lord's Supper, administer the sacrament of Baptism, perform a service of Christian marriage when invited by the session or other responsible minister and when allowed by the state; perform a service at a funeral, and have a voice and a vote in the meetings of Presbytery.
 - Leah Hathaway (Jewel Lake Parish): The Ministry Commission approved the request of the council (session) to renew Leah's commission for three years. Responsibilities granted under this commission: administer the benevolent fund for the community; serve as volunteer chaplain at the Alaska Native Medical Center and in the community; provide pastoral outreach/sacraments for Jewel Lake Parish and community as requested; provide healing ministry through Anchorage Healing Touch Clinic and the community; serve as liaison for Presbytery of Yukon/Presbyterian Disaster Assistance to the Alaska VOAD (Voluntary Organizations Active in Disaster); administer the sacraments; and have voice/vote in presbytery.
 - Merle Apassingok (Gambell Presbyterian Church): The Ministry Commission approved the request of the session to renew Merle's commission for three years. Responsibilities are those granted under Merle's original commission: lead worship services and preach the gospel; administer the Lord's Supper; administer the sacrament of Baptism; perform services of Christian marriage; perform funeral services; and have a voice and vote in the meetings of the presbytery.
- 4. Moderator Appointments [February 27, 2020]
 - Kuukpik PC (Nuiqsut): Elder Olivia Cabinboy. Rev. Tim Carrick will serve as Olivia's mentor.
 - Olgonik PC (Wainwright): Elder Cora Akpik. The commission is seeking a mentor for Cora.

- Approved commissioned pastor in-training Mary Ellen Lucas' request for financial aid to attend the *Empowering Commissioned Pastor Conference*, to be held May 13-16, 2020 in Richardson, Texas. Event is sponsored by the Synod of the Sun. The MC designated \$600 to be taken from the Leadership Development Fund. [February 27, 2020]
- Recommended that presbytery schedule the mental health first aid training on the first day of the winter presbytery meeting [October 12, 2020]
- Granted approval of Trinity's request to form a Pastor Nominating Committee.

Our submission of those initiatives was based on the recognition that we, as members of the presbytery would need to give our support through time and effort to accomplish them. We remain ready to do so.
- We would like to suggest to the presbytery leadership that they devote some portion of a Presbytery training session to the issue of intergenerational trauma, its effects, impacts, and what we can do to address it.
- We understand the current trend in youth suicide is accelerating. This is an area needing our attention and seems to be related to the effects of intergenerational trauma.
- We believe that we need more community-based church cooperation much like the interagency cooperation that exists in the fire, first responder, and social services areas. We encourage innovative thinking on this.

 We invite all attendees to walk down the hall on break or at the end of presbytery and take a look at the 600+ resources there are in the library which belong to the presbytery and which are available to be checked out and used.

 - \circ Approved the recommendation to designate Philippians 4:4 7, as the theme verse for the Winter Presbytery Meeting?
 - "Rejoice in the Lord always; again, I will say, Rejoice. Let your gentleness be known to everyone. The Lord is near. Do not worry about anything, but in everything by prayer and

supplication with thanksgiving let your requests be made known to God. And the peace of God, which surpasses all understanding, will guard your hearts and your minds in Christ Jesus" (NRSV). [Jan. 16, 2020]

- o Approved the recommendation that elder commissioners answer the following questions during their elder reports at the February 28-29, 2020 Winter Presbytery Meeting: [Jan 16, 2020]
 - ➤ What is your congregation rejoicing about?
 - ➤ What are any anxieties you would like to bring to God in prayer?
- o Approved Intergenerational Arctic Ministries (IAM) short-term \$40,000 interest-free loan, to be taken out the Synod Building Sale Fund. [Jan. 16, 2020]

Request rationale as presented in the email request:

At the moment, IAM has 10 employees, and other monthly bills, which IAM must first pay, and then ask for reimbursement from already approved grants. IAM has plenty of money in the grants but, in pure bureaucratic nonsense, that money is only available for reimbursement, which requires having thousands of dollars in our account upfront to pay the bills, before asking for reimbursement. Unfortunately, the only money IAM has is this same grant money, which is only for reimbursements!!!

So far, the Arctic Slope Community Foundation (ASCF), who administers the grants, has not been willing to give IAM part of the funds as reserves to use in paying the bills in the first place. As a result, payroll was two weeks late this month, as IAM waited for reimbursements from previous expenses. The way IAM has been able to make this work has been by not reimbursing the presbytery. Currently there is approximately \$15,000 owed to the presbytery which, as I said, remains unpaid so that IAM has some cash in its account to meet payroll.

There is a long-term solution. Much of the grant money originally came from the North Slope Borough. The NSB Mayor's office is therefore working with IAM to get some of that money freed from the ASCF's bureaucratic rules, to be available in a way that will solve the cash flow problem. However, ASCF is in the process of changing its CEO, and so no changes are happening, probably, until that change is complete--maybe a couple more months. IAM is stuck in a hard place.

- February 27, 2020 Meeting:
 - Approved funding for the Pastor Retreat/Boundaries Training: \$5,000 budgeted for the pastor retreat, with any remaining expenses to be taken out of the Lay Leadership Training or Transformation Funds.
 - o Designated Christian Education as the focus of the fall, 2020 fall stated meeting.

Presbytery of Yukon Administrative Commission Report From Anchor Presbyterian Church February 14, 2020

In late 2018, the Presbytery of Yukon approved the following action:

- Presbytery of Yukon assume original jurisdiction and appoint Rev. Britt Johnson, Rev. Ian MacInnes-Green, RE Renee Savage, and RE Clyde Kaneshiro to an Administrative Commission (AC) for Anchor PC for a period up to two years, for the purposes of performing the duties of the session as found in G-3.0201; helping the Anchor congregation discern its future direction, and explore possible options in cooperation with Native Ministries.
- That the Ministry Commission be authorized to seek a fifth member, preferably an Alaska Native elder, to serve on the AC and to replace members as needed, and
- That the AC be expected to give a report at each stated meeting of presbytery.

Before the new AC was able to meet, Rev. MacInnis-Green was called to a congregation in Michigan. A new minister member was sought, and Rev Elizabeth Schultz was appointed to replace Rev. MacInnis-Green. Jenny Alowa, elder from First Presbyterian Church in Anchorage, and Alaska Native (Yupik) was appointed to fill the elder position on the Administrative Commission.

Since May 22, 2019, our Administrative Commission comprised:

- Rev. Dr. Britton Johnston (Moderator and Clerk of Session)
- Rev. Elizabeth Schultz
- Elder Renee Savage
- Elder Clyde Kaneshiro
- Elder Jenny Alowa

This group met in 2019 on the following dates:

March 13 (without Rev. MacInnis-Green or Jenny Alowa), May 22, August 19, and September 18.

The major topics considered in 2019 were:

- Management of the ministry to the homeless
- How to be advocates for the homeless in Anchorage
- Communication and scheduling of meetings of the Administrative Commission
- Summer Rummage Sale
- Seeking help from the presbytery's Administrative Assistant for the task of reconstructing our Session Records.
- Recommending an overture on a declaration of Jubilee to the Presbytery.

We look forward to 2020 as a season of discernment of our calling to congregational life and mission.


Executive Presbyter's Report 27 February 2020

The Roll of Vision in Congregational Ministry

We are well aware that participation in churches has been on a steady decline in the North America for the past 50 years. Congregations that attract newcomers generally show the following characteristics:

- Members with a vital relationship with Jesus Christ, characterized by daily spiritual practices that keep that relationship alive (practices like prayer, Bible Study, service, and meaningful Christian fellowship).
- An urgent purpose/mission that the church strives to fulfill, with public worship and Bible Study that connects that purpose to the gospel we proclaim.
- Discipleship and Fellowship efforts that equip believers for their mission, and builds the teamwork needed for that mission.

The <u>Vital Congregations Initiative</u> of The Presbyterian Church (USA) seeks to help congregations develop the vision and practices for this kind of work. The Roll of Pastors in Congregations

At our October 2019 meeting of presbytery, we held a panel discussion on *Grow-Your-Own Leadership*, where we especially discussed the potential for Commissioned Pastors (CPs) in congregations. This model is an important one that is serving some of our churches well. Yet, this raises the question about the unique gifts of Minister of Word and Sacrament (MWS). Is the purpose of the role of the

MWS changing? Does it require more time and skills for mentoring CPs and congregations pursuing mission without a MWS? Are MWS only for privileged ministry settings? How does the unique gifts of CPs and MSWs make sense in ministry, today? I ask these questions noting the following

- The fastest growing church in the presbytery over the past five years has been the Utqiagvik Presbyterian Church, which has two CPs, a full-time MSW, and a part-time MSW.
- Recruiting effective partners from Presbytery of Yukon Churches for IAM ministries has been easiest in churches with CPs.
- The Kuukpik Presbyterian Church in Nuiqsut is exploring whether to form a Pastor Nominating Committee, wondering if this is the moment when their mission requires and MSW.
- New forms of leadership have begun to develop in at least a couple of settings that have neither
 a CP, nor MSW. These include regular worship leaders who are not ruling elders, informal
 decision-making because the session does not meet regularly. Some of these new forms of
 leadership seem to be fairly effective, at least at the moment. However, it is not clear how these
 new forms of leadership should be understood in the Presbyterian system.

My observation is that God is moving in our presbytery, but we need to pay attention to these new movements of the Spirit, in order to discern how God is leading us, and in order to avoid the pitfalls that come from failure to pay attention.



Status of Sharing the Exec with Intergenerational Arctic Ministries

Since March of 2018, the presbytery has commissioned me to put half of my time into service as executive for Intergenerational Arctic Ministries (IAM), a healing ministry to address the social ills in our Native Ministries Region. IAM entered into a contract for those services, which means IAM paid ½ of my salary and a significant portion of my travel expenses. This has allowed the presbytery to birth a new ministry in Alaska, while saving the presbytery around \$34,000 in 2019.

IAM's work has grown over the past year to the point where it was straining my ability as a part-time executive. Last week the IAM Board of Directors voted to make the Rev. Charlie Brower (retired from the United Methodist Church) Co-Executive with me, both of us working ½ time for IAM. Charlie and I have just begun working out how we share that job. However, we had been working together on IAM goals since November, and this has definitely helped restructure the work to a more manageable load. As a result, I am trying to increase my work in a few areas, such as Pastor-to-pastor support.

One of the biggest hurdles IAM has faced has been cash flow. The Arctic Slope Community Foundation, was assigned to serve as IAM's fiscal sponsor and to administer the grant funds. Unfortunately, the ASCF set up parameters which, by default required IAM to already have funds in their account to meet expenses, expecting to reimburse those funds as they were used. However, the sponsor failed to release the upfront funds, making it impossible to move forward. The presbytery Leadership Team therefore released \$40,000 as an interest-free loan while we negotiate this problem.

Recently, the ASCF hired Patuk Glenn as the new Executive Director on their team. As she comes up to speed, we expect to be able to negotiate new financial processes. In the meantime, IAM is very grateful to the presbytery for keeping this ministry moving in a time of real financial difficulty.

The 2018 minutes of Yukon Presbytery have been reviewed with the following notations and actions (by page):

Irregularities – None cited.

<u>Delinquencies</u> (Requires remedy, reported to the Synod) - The following items shall be corrected and reported to the Synod.

10. Session Records Review - the record shows session minutes some church records were reviewed, but does not address those not reviewed. The report should mention that further reviews are underway if so, or list churches that have not submitted records, or the plan for reviewing the rest of the churches, etc. If a church is delinquent, this should be reported and the action (or no action) of the presbytery also reported. During 2020, the Clerk should complete the report and progresses made, etc.

Report of Exam Readers - If the presbytery did not elect, or designate CPM to elect exam readers, the presbytery should do this during 2020. If they were elected and not reported, this should be reported in he next stated clerks report as a correction to former minutes.

Child Protection Policy (G-3.0103) - The presbytery is directed to develop and approve a policy by June 30, 2020 and report its action to the synod stated clerk.

Exceptions Recording/Parliamentary Errors – None cited.

Suggestions/Comments

- 9. Insurance This detail is not required, only attestation is needed, or a attach a copy of the certificate of insurance attached to the minutes or included in the supplement.
- Summaries of Remarks (many places) "In an ordinary society, the minutes should contain mainly a record of what was done at the meeting, not what was said by the members;" and
 - "The name and subject of a guest speaker can be given, but no effort should be made to summarize his remarks." RONR 11th Ed. p. 470.

These are excellent (even amazing) minutes and go far beyond what is required or suggested by Roberts Rules of Order. While an excellent historical record, comments made by presenters, testimonies, etc. need not be recorded, but can be at the discretion of the Clerk:

• Leadership Team – Since this team is empowered and delegated power to act on behalf of the presbytery (bylaws Article VII), does it function as and is it subject to the rules of a commission (ruling/teaching elders in numbers as equal as possible, "a full record of its proceedings" incorporated into presbytery records, etc., as in G3.0109b)? Since it is acting on behalf of and *as* the presbytery, it might be good to have the principles of diversity, representation, and ruling/teaching elder balance present in this group.

The record shows the constitutional level of accountability in G-3.0106, 5th paragraph, is being fulfilled, but as the named Board of Trustees of the Corporation, a full record of its proceedings (minutes)

must be created and preserved. Is this being done, and if so, please include a notation in the report of the Leadership Team that a full record has been created and is available, and where.
